# AGREEMENT for Cooperation and Partnership

City of Krasnoyarsk

29 December, 2015

The Central Siberian Chamber of Commerce and Industry, in the person of the Chairman, Rafael Marsovich Shageev, acting by virtue of the Articles of Association, hereinafter referred to as "The Partner", on the one hand, and

The Krasnoyarsk Regional Sports Non-Governmental Organization (KRSOO) "Kendo Federation", in the person of the President, Viacheslav Nikolayevich Byk, acting by virtue of the Articles of Association, hereinafter referred to as the "KRSOO Kendo Federation", on the other hand, and jointly referred to as the "Participants in the Agreement", entered into the Agreement as follows:

#### 1. Subject Matter

- 1. The subject matter of this Agreement is integration of efforts of the Participants in the Agreement in the field of development and implementation of measures aimed at:
- 1.1. Assistance to wide range development of physical culture and sports, healthy style of living, involvement of possibilities of Kendo and martial arts in the Russian Federation and the Krasnoyarsk Krai for these purposes;
- 1.2. Physical and spiritual upbringing of younger generation in the spirit of patriotism;
- 1.3. Assistance to development of the field of production and sales of sporting goods;
- 1.4. Development and promotion of the Kendo sports in the Krasnoyarsk Krai as one of the promising and modern trends of martial arts;
- 1.5. Involvement of possibilities of the Japan and international Kendo Federations for establishment and development of international economic, industrial, trading relations with the companies and entrepreneurs of the Krasnoyarsk Krai;
  - 1.6. Development and strengthening of inter-regional and international relations;
- 1.7. Extension of practice of the international cooperation in the field of sporting industry between Russia and Japan.

## 2. Principle of Cooperation

The Participants in the Agreement in the course of cooperation are governed by the following principles:

- 2.1. Equality of participants;
- 2.2. Respect and consideration for interests of the Participants;
- 2.3. Interest of the Participants in involvement into the contractual relations;
- 2.4. Strengthening and development of partnership on the democratic basis;
- 2.5. Apparent authority of the representatives of the Parties;
- 2.6. Voluntary basis upon incurrence of obligations by the Parties;

- 2.7. Feasibility of obligations incurred by the Parties;
- 2.8. Enforceability of fulfillment of the adopted solutions, concluded agreements;
  - 2.9. Responsibility of the Parties.

## 3. Implementation of the Purposes of the Agreement for Cooperation and Partnership

In the scope of each field mentioned in Item 1 of this Agreement, the Participants in the Agreement develop and approve documentation which determines actual purposes, terms, responsible persons.

#### 4. Fields of Cooperation

The cooperation between the Participants in the Agreement involves the following issues:

- 4.1. Assistance in coordination and implementation of the governmental policy in fulfillment of socially important recreational measures in the Krasnoyarsk Krai;
- 4.2. Sharing experience and establishment of new business relations with thee partners from Japan;
- 4.3. Arrangement and holding of joint seminars, conferences and other events aimed at promotion of healthy life style and as well as promotion of health care;
- 4.4. Arrangement and holding of events aimed at the development of the Kendo sports in the Krasnoyarsk Krai;
- 4.5. Finding and support of talented sportsmen, arrangement of worthy and available conditions for going in for sports.

## 5. Results of Activity

The final and intermediate results in the scope of this Agreement can be applied by the Participants in the Agreement.

### 6. Authorities, Rights and Obligations of the Parties

#### The KRSOO Kendo Federation:

- 6.1. Informs and involves its Partner into participation in the events aimed at development of the Kendo sports in the Krasnoyarsk Krai.
- 6.2. Arranges interaction between the Partner and the specialized competent centers.
- 6.3. Provides for extension of the system of informational activities with children and adults in the Krasnoyarsk Krai aimed at promotion of healthy life style.
- 6.4. Arranges acquisition and processing of required information, provides consulting and organizational support upon development of appropriate schedules and projects oriented at the development of the Kendo sports in the Krasnoyarsk Krai.

#### The Partner:

- 6.5. Arranges international meetings, conferences and seminars in the scope of this Agreement, involves the partners of the Central Siberian CCI into participation;
- 6.6. Assists in arrangement and implementation of the projects by the KRSOO Kendo Federation.
- 6.7. Involves and invests after coordination with the KRSOO Kendo Federation its own and borrowed resources, tangible and intangible assets into the development of the Kendo sports in the Krasnoyarsk Krai.
- 6.8. Invites for participation in the events held by the KRSOO Kendo Federation, sponsors, investors, executive authorities and legislative bodies.

#### 7. Final Provisions

- 7.1. This Agreement does not incur any financial obligations for the Participants in the Agreement. The financial relations are established by separate agreements.
- 7.2. Any alterations and amendments to this Agreement are arranged as supplemental agreement and are valid from the date of its signing by all Partners in this Agreement.
  - 7.3. This Agreement is valid from the date of its signing by the Parties.
- 7.4. In any other cases, not stipulated by this Agreement, the relations between the Participants in the Agreement, are governed by valid laws.
